1. What changes, if any, in the curriculum for students would you like to see?

I feel that enhancements to curriculum delivery methods, rather than curriculum itself are most important currently. The Covid-19 situation has pointed out that we do not have distance learning in place in any meaningful way. A robust distance learning infrastructure could serve to enhance our curriculum offerings within the limits of teaching resources as our student population declines.

2. How do you feel about the present school consolidation plan?

When our student population declines, consolidation is inevitable. The current plan asks sacrifice from students, families, teachers and service personnel but, none from school level administration or the central office administration. I find this unacceptable while the current Board obviously does not. Our dollars must go into teachers and service personnel who keep things running and not solely the administration.

3. What experience, training or education do you have that makes you the best qualified candidate for board of education?

Two Master's degrees in business and 35 years of experience in management of various enterprises. The BOE is not a business but many aspects of its management are similar as you must be fiscally prudent and get the most from each dollar. Couple that background with 11 years as a college teacher. I appreciate the challenges faced by classroom teachers.

1. What changes, if any, in the curriculum for students would you like to see?

2. How do you feel about the present school consolidation plan?

Due to declining enrollment, outdated buildings, and limited resources more schools will eventually need to be closed, based on the ten year Comprehensive Educational Facilities Plan for 2021-2030. **3. What experience, training or education do you have that makes you the best qualified candidate for board of education?**

Most importantly I am a retired teacher. As a current board member I care most about our students, employees, and service personnel. I supported the hiring of our new superintendent as well as the initiatives that led to the increase in our Math and Language Arts scores. In addition under my watch the levy and bond issue passed.

Assuring instructional time to ninety minutes for math in elementary will allow for intervention or enrichment and 60 minutes in secondary would be beneficial for students. I congratulate students and teachers on increased math scores and recognition by the state this year.

2. How do you feel about the present school consolidation plan?

State funding has decreased because of a declining student population. The board must address reducing costs. What other cost saving measures are in place? What factors led to decisions on each school? Was input from the school community considered? Will staffing be adequate? Will the schools' cultures blend or be lost?? I will weigh each aspect to determine future consolidations.
