Our members along with others made enough noise to help keep several bad bills from passing but that doesn't mean that they won't be back in a late summer ad hoc session when the governor makes his discretionary call. Sneaky bills will no doubt be back.

# Primary Election Dates and Deadlines





### **GoVoteWV**

**January 1 - May 8, 2024 - Absentee Application Period -** Eligible Absentee Voters can send an absentee ballot application to their County Clerk in person, by mail, or electronically.

**January 1 - May 8, 2024 - Absentee Application Period - Military or Overseas** Voters may request an absentee ballot.

January 8 - January 27, 2024 - Candidate Filing Period

March 26, 2024 - Write-in Deadline

March 29, 2024 - County Clerks begin mailing absentee ballots to voters from whom they received applications.

April 23, 2024 - Voter Registration Deadline

May 1 - May 11, 2024 - Early Voting in Person - Voter may vote an early ballot at the county courthouse, an annex or a designated community voting location during normal business hours. Early voting must be conducted between 9 a.m. and 5 p.m. on the last 2 Saturdays before the Primary Election.

May 7 - Noon, May 14, 2024- Emergency Absentee Voting

Registered voters and other qualified voters in the county are authorized to vote an emergency absentee ballot in the following circumstances may be eligible to receive an emergency absentee ballot in the following circumstances:

- Voter is in the hospital on Election Day;
- Voter is a replacement poll worker appointed after the period for Early Voting;
- Voter is in a licensed health care facilities within an adjacent county or within 35 miles of the county seat (county policy required;)
- Voter is in nursing home within the county if he or she has resided there for a period of less than 30 days (county policy required); or
- Voter becomes confined, on or after the seventh day preceding an election, to a specific location within the county because of illness, injury, physical disability, or immobility due to advance age or other medical reason(county policy required).

May 8, 2024 - Deadline for Absentee Ballot Applications

May 11, 2024 - Deadline for Early Voting in Person

May 13, 2024 - Deadline for Hand-Deliver Absentee Ballot to the Clerk's Office

**May 14, 2024 - ELECTION DAY** 

May 14, 2024 - Absentee Ballots Received Electronically from Eligible Voters Accepted - Absentee ballots submitted electronically by eligibile military and overseas voters and eligible voters with physical disabilities are accepted by close of polls.

May 15, 2024 - Absentee Ballots without Postmark Accepted

May 20, 2024 - Absentee Ballots Postmarked by Election Day Accepted



## WV Health

This year's session was challenging for West Virginia's health needs.

Positive outcomes include:

HB 4933 increased adult Medicaid recipient's dental benefits from \$1000 annually to \$2000. This will enable individuals to obtain dentures in addition to routine dental care.

HB 4874 passed, regarding infant and maternal mortality information. West Virginia babies and mothers are at high risk for poor outcomes during and after birth.

SB 443 will require pricing transparency from pharmacies who contract with PEIA.

A bill requiring SNAP recipients to obtain employment failed.

All bills further restricting reproductive and gender affirming care failed.

#### Concerns:

HB 5105 passed the Senate and House. This bill would loosen the state's strong school vaccine laws. Governor Justice has received multiple calls from physicians and educators asking for this bill to be vetoed.

The State's current budget failed to fill the \$114 million dollar gap in Medicaid funding.

The budget also decreased the funds to care for individuals with intellectual and developmental disabilities.

There will be a special session in May to address the current budget. Hopefully there will be additional funding for these important health related needs for West Virginians.

You can go for a deep dive at <u>WV SOS - Elections - Candidate</u> - <u>Online Data Services</u> to see the field and take away your own impressions of the candidates. When you click on a

candidate's name you will find links to their website or sometimes a Facebook page. One party has a competitive field with multiple candidates for an office while one party is lucky to have *a* candidate. The last redistricting in WV divided incorporated municipalities and added rural voters in disproportionate numbers giving one party a distinctive edge, bringing the illusion that one party had become almost extinct, which is not really the case, they just become disenfranchised.

One candidate describes himself as a businessman and in this article <u>Self described</u> <u>"political outsider" Chris Miller wants to lead West Virginia - WV MetroNews</u> is said to already be operating 26 businesses that employ 650 people and sees hope in treating taxpayers like customers.

Several WV Congressional and US Senate candidates were those who signed on to the Freedom Caucus to not certify the 2020 election, but whether that was an act of treason or not isn't a question that anyone seems to be raising. Newsletters from some current incumbents can be found with biased political misinformation and accusations that are not supported by factual references. Enough said.

Public debates do not always remove the veneer from a candidate to see them as they really are. By reflex they will fall back to reciting what they want voters to hear, using pushbutton party rhetoric and words that stimulate a response that they think will excite their constituents. You will know when to run as far away as you can from a candidate when you aren't getting constructive and practical plans to make West Virginia a genuinely better place to live.
